Michael HOLT Junr: is appointed Overseer of the Road from the Pine ford on Haw River to the fork of the Road Westward And from TROLLINGERS Ferry into said Road: Ordered that William RANEY, John FEARSON, Benja. PHILLIPS, Jesse PHILLIPS, Jacob HOLT, John GANT, Thomas SHARPE, Adam TROLLINGER, Henry TROLLINGER and John POWELL lay out and Open the New Road from the Ferry into said Road and that their Hands work on said Old Road under the Overseer aforesaid.

William REED Sherriff comes into Court and Protests against the Goal of this County that it is not Sufficient to hold Prisoners.

Ordered that the Account of William CHURTON Esqr. for six Pounds ten Shilling Proclamation Money by him Expended for the use of the County be paid him out of the County Tax:

Ordered that Francis WILKINSON be Appointed Overseer of the Road from TAYLORS Ford to STAGGS Creek and James BIRD from thence to where he dwells and that they keep the said road in good repair.
