Thomas POE on comm to visit the congregation about their stand on the Rules of the Conference.

Thomas POE delegate to assoc.

Thomas POE complained to the church about the conduct of Larkin POE in consequence of intemperance.

NOV 1835

Case of Larkin POE - he was absent. Case Continued until next conference.

Thomas POE to let him know church wants him to attend next conf.

**JAN 1836** 

Larkin POE charged with public transgression. Confessed his wrong as he had previously done and dsired to remain with the bretheren

in the church. Restored to the fellowship.

**MAY 1836** 

Thomas Poe to deliver a message to Friendship Church.

JUL 1836

Thomas POE, delegate; Larkin POE, alternate

AUG 1836

Thomas POE, delegate to Assoc; Larkin POE, alternate OCT 1836

Thomas POE admonished Larkin POE for his transgression and told him to come to church and make satisfaction for his

transgression. Larkin let him know that he wished the church to be at as little trouble with him as possible and failing to attend as requested

to do, and having been guilty of the like transgression again and again, he was unanimously excluded from the church.

JUL 1837

Thomas POE on comm to find out how to dipose of the resolutions to Philadelphia Church.

AUG 1837

Thomas POE alternate delegate to dist mtg

**NOV 1837** 

James , Lucy and Martha L. POE received by experience of grace

FEB 1838

James POE on comm to select site for new meetinghouse

Thomas and wife, Mary POE dismissed by letter.

Seems as if James POE is the only POE left until SEP 1839 when Calvin and Simon POE joined by experience of grace. Also R.E. was

Mary Ann CATES. Restored at this time were Rebecca ASHCRAFT and Martha ROGERS, formerly Martha CATES.
