THE POES AND THEIR NAME HISTORY by Aunt Amelia Poe

The name of Poe is believed by some authorities to have been of ancient Saxon origin, but its meaning is not clear. It is found on the records of old England in the various forms of Pos-Poo-Poy-Pau-Pooe and Poe of which the last is the generally accepted form of today. There seems however to be good reasons to suppose that the name of Poe was in many parts of Great Britain used as a contraction of Powell, or Poell, a Welsh name of great antiquity, which is said to have been derived from AP Howell.

Families of the name of Poe were to be found at early dates in the counties, of Derby and Nottingham, in England, in the latter of which places, one William Poo or Poe died about 1557 leaving five children, -Richard, Edmond, Joan, Alice, and Thomas of whom the first made his "Will" in 1564 naming his wife, Margaret and his son, Richard.

One Richard Poe was under-keeper for Sir John Byron, father of the first Lord Byron. This line is said to have made its home on the manor of Papplewick, in Nottinghamshire, and was represented in the latter part of the 16th century by Dr. Leonard Poe and his brother Anthony Poe, who married Alice Frost and had issue by her of-William Poe (removed to county Tyrone, Ireland)—John Thomas (made his home in Co. of Tipperary, Ire.)—Anthony (Capt. of the Parliamentary Army in Ire.) and in England)—Richard, Alice, Ann and Elizabeth.

Thomas, son of Anthony Poe, was the father of Richard, Emanuel, Thomas, Mary and Eleanor: of whom the first was the father of Thomas, Edward, John Anthony, Richard, William, Robert, Elizabeth, Arabella, Jane and Mary. The second was the father of William, Emanual, James, Thomas, Joseph, Una and Elinor, all of whom were living at the beginning of the 18th century.

Anthony, son of Anthony Poe had issue by his wife, Mary of: Daniel, Anthony, Sarah, Anne, Elizabeth, and Mary, of whom the first died in the latter part of the 17th century, leaving at least two sons, Samuel and James.

About this time another family of Poes were living at Dring, in the Co. of Cavon, Ireland, and was headed by one David Poe, who had issue by his wife Sarah: John, Alexander and Anne, of whom the first two emigrated to America in the early 18th century. Unfortunately, the immediate family of the imigrant, Alexander is not known definitely.

John Poe, eldest son of David, married Jane, daughter of the Rev. Robert McBride, in 1741, and settled in Penn. He had issue-James, Samuel, John, Robert, David, George, Hester, Mary, Jane and William. David married Elizabeth Cairnes, George married Katherline Dawson, both had issue. William married one Frances Winslow, by whom he had a large family, they moved to Georgia.

David, son of the emigrant John, removed to Baltimore, Md. with his wife, Elizabeth Cairnes, and was the father by her of: John Hancock, William, David, George Washington, Samuel, Mary (Maria), and Elizabeth. David Poe, of Baltimore, was Deputy Assistant Quartermaster, General of the Revolutionary War.

David, Jr., son of the last mentioned David Poe, married the widow, Elizabeth, (nee Arnold) Hopkins in 1805 and had issue by her of among others, the famous Poet. Edgar Allen Poe, who was born in Mass. in 1809, died in Md. in 1849.

Another family of the name of Poe, emigrated to America, George Jacob Poe, from Prussia, Germany, to Md. in 1745. It was from this line that the noted Civil War officer General Orlandor Metcalf Poe was descended, also the Memorable Indian Fighters—Adam Poe and Andrew Poe. They fought, Big Foot, Chief of the Wyandotte Nation and six other Indians on the Ohio River. Poe, Twp., Hancock co., Ohio, has been named for them. Memorial to their brave deed. We do not know at this writing whether there is any connection between these Poes and the ones that migrated from Ireland.

The descendants of these various branches of the Poe Family in America have spread to

practically every State of the Union and have aided as much in the growth of the country as their ancestors aided in the founding of the Nation. They have been noted for their courage, energy ambition, industry, integrity, piety, love of adventure, power of will, mental ability and leadership.

David, John, Thomas, William, Edward, James, Samuel, Richard, Anthony and Emanuel are some of the Christian names most highly favored by the Poe family for its male members. The Coat of Arms of the Poe family is described as follows:

ARMS--"or a fesse between three crescents azure, issuing flames, proper."

CREST -- "On a wreath of the colours, a Boar's head, couped erect or pierced through by a broken spear." Sources: (Arms taken from Burkes, "General Armory Argent." 1884. The above data has been compiled chiefly from the following sources:

James Purefoy Poe of Harley Park, Co. Tipperary, J.P. Co 'S. Lilkenny and Tipperary was born December 21st 1859.—LINEAGE-Capt. James Poe, 3rd son of Emanuel Poe (see Poe of Riverston) purchased the Harley Park estate. He married Mary Cooke of Kiltinan and died, 1728, leaving issue: James of whom presently. 2.—Mary, married William. Drewe of Kilveny. 3.—Susan married 1729, Purefoy Poe, son of Wm. Poe of Knock and D.S.P. The son James Poe of Harley Parks, m. Bridget, daughter of the Hon. Richard Power, Baron of the court of the Exchequer in Ireland. Edgar Allen Poe's Letter to Mr. William Poe Augusta, Ga. Dear Sir:

Richmond, Aug. 20, 1835

I received your very kind and complimentary letter only a few minutes ago, and hasten to reply.

I had long been aware that a connection existed between us--without knowing precisely in what manner. Your letter however has satisfied me that we are 2nd cousins. I will briefly relate to you what little I have been able to ascertain or rather to remember, in relation to our families. That I know but little on this head will not appear so singular to you when I relate the circumstances connected with my own particular history. But to return, my paternal Grandfather was Gen. David Poe of Baltimore originally of Ireland, I know that he had brothers-two I believe, but my knowledge extends only to one, Mr. George Poe. My grandfather married when very young, a Miss Elizabeth Cairnes of Lancaster, Pa. by whom he had five sons Viz: George (who died while an infant), John, William, David, and Samuel. Also two daughters, Maria and Eliza, both married young. Maria married a Mr.

Wm. Clemm, a gentleman of high standing and some property in Baltimore. He was a widower with five children and had, after his marriage to Maria Poe, three other--Viz: 2 girls and a boy of which a Girl, Virginia and a boy, Henry are still living. Mr. Clemm died about 9 years ago without any property whatever, leaving his widow desolate and unprotected and little likely to receive protection or assistance from the relatives of her husband-most of who were opposed to the marriage in the first instance--and who opposition was no doubt aggravated by the petty quarrels frequently occurring between Marie's children, and Mr. Clemm's children by his former wife. This Maria is the one of whom you speak and to whom I will allude again presently, Eliza, the second daughter of the General, married a Mr. Henry Herring of Baltimore, a man of unprincipled character and by whom she had several children. She is now dead and Mr. Herring, having married a (old letter torn out when opened) communication with the family of his wife's sister--Mrs.--the window of Gen. David Poe, and the mother of Maria died only ---ago at the age of 79. She had for the last 8 years of her life been entirely to bed, never in any circumstance leaving it during that time. She had been paralyzed and suffered from many other complaints. Her daughter, Maria, attending to her during her long and tedious illness with a Christian and Martyr-like fortitude, and with a c constancy of attention and unremitting affection which must exalt her character in the eyes of all who know her-Maria.

In relation to my Grandfather's brother George, I know but little, Jacob Poe of Fredericktown, Md. is his son, also George of Mobile and I presume your grandfather, William Poe. Geo. Jacob (sic) Poe has two sons--Neilson and George, also one daughter, Amelia. My father, David died when I was in the second year of my age, and when my sister, Rosalie, was an infant in arms. Our mother died a few weeks before him. Thus we were left orphans at an age when the hand of a parent is so peculiarly requisited. At this period, my grandfather's circumstances were at a low ebb, he from great wealth having been reduced to poverty. It was therefore in his power to do little for us. My brother, Henry he took however under his care, while myself and Rosalie were adopted by a gentleman

in Richmond where we were at the period of our parents death. I was adopted by Mr. John Allen of Richmond, Va. and she by Mr. McKenzie of the same place. Rosalie is still living at Mr. McKenzies still unmarried and is treated as one of the family, being a favorite with all. I accompanied Mr. Allen to England in my 7th year, and remained there at school five years, since which I have resided with Mr. Allan until a few years ago. The first Mrs. Allan, having died and Mr. Allan having married again, I found my situation not so comfortable as before, and obtained a Cadet's appointment at West Point. During my stay there, Mr. Allen died suddenly and left me-nothing. No will was found among his papers. I have accordingly been thrown entirely upon my own resources. Brought up to no profession and educated in the expection of an immense fortune (Mr. Allen having been worth \$750,000, the blow has been a heavy one, and I had nearly succumed to it's influence and yielded to despair. But by the exertion of much resolution, I am now beginning to look upon the matter in a less serious light and although struggling still with many embarrassments, am enabled to keep up my spirits. I have lately obtained the Editorship of the Southern Messenger, and may probably yet do well.

Mrs. Thompson, your Aunt, is still living in Baltimore, George Poe, of Baltimore allows her a small income. In conclusion, I beg to assure that whatever aid you may have it in your power to bestow upon Mrs. Clemm will be given to one who well deserves any kindness and attention, would to God that I could at this moment aid her. She is now while I write, struggling without friends, without money and without health to support—and two children. I sincerely pray God that the words which I am —may be the means of inducing you to unite with your brothers and—ends, and send her that immediate relief wh—it is utterly out of—power to give her just now and which, unless it reach her soon will, I am afraid reach her too late. Entreating your attention to this subject, I remain,

This record was made up in 1906 from family papers now in the possession of Amelia Poe, daughter of Neilson Poe and Josephine Emily Clemm Poe.

David Poe, Scotch-Irish from Parish of Fenwick, in Ayrshire Scotland-intermarried with Allans and Galts--They belonged to the Scotch Protestants who migrated to Ireland, Dring in Parish of Kildallen, Co. Cavon. David Poe and wife Sarah, living in Dring, had 3 children, John, Alexander, and Anne. John Poe was named for his Grandfather, John Poe. This John Poe, in September 1741, married Jane McBride of Ballymoney Co. Antrim, Ireland and this marriage was probably performed by John, Lord Bishop of Clogher, or by Jane's father, the Rev. Robert McBride.

Alexander Poe, brother of John's came to America in 1739, settled at Marsh Creek, near Gettysburg battlefield in Lancaster Co., Pa. He wrote back to Ireland and his brother, John Poe and wife, Jane McBride and sons David and George came over in 1743.

David Poe died in 1742 and he and his wife, Sarah are buried in Dring, Ireland.

John Poe and wife, Jane McBride of Donegal, Donegal Co., Ireland landed at New Castle, Del. with children and went at once to Lancaster Co., Pa. and afterward to Cecil Co.Md. Jane McBride was sister of McBride, Admiral of the Blue and Member of Parliament for Plymouth, in 1785. John and Jane had 10 children: namely—

- 1. David-born in Ireland.
- 2. George-born in Ireland
- Robert-died in the West Indies.
- 4. John-Taken prisoner at battle of Germantown, 1777--died on the prison ship, Jersey at New York.
- 5. Samuel
- 6. Jane
- 7. James

- 8. Hester
- 9. Mary
- 10. William-born 1754-died 1802-had 7 children.

Of these Robert, John, Samuel, James and Jane who died in Annapolis, left no issue.

Hester and Mary married had one child each but these children left no issue. So there were left

David, Grandfather of the poet, Edgar Allen Poe-George from whom the Poes in Md. spring and wil
liam Poe.

John and his wife removed to Baltimore where he died in 1756.

The first city directory of Baltimore, published in 1786 contains the name of Jane Poe, widow, German St. between Howard and Hanover. This property was owned by the family. She died July, 17, 1802, aged 96 and is buried in Westminister Churchyard, lot number 129, corner of Green and Fayette Sts. Baltimore, Md.

"Burkes Landed Gentry" gives a full record of John Poes ancestry, showing for instance that Dr. Poe, physician to Queen Elizabeth came from Donegal, and was of the family. William Poe, the youngest child went to Ga. and married Frances Winslow. He died in Augusta. Ga. They had the following children--

- 1. Robert--probably born 1775, died 1854, had son William C., Mary and others not known.
- 2. William--13 children--born in 1802 was the baby of the family.
- 3. Washington--distinguished lawyer, member of Congress--born in 1800.
- 4. Matilda
- Forsythe
- 6. Francis
- 7. Annie

These are the progenitors of the Poes in Ga.--Atlanta, etc., with the exception of one family in Mobile, Ala. and another in Barnville, S. C. which descended from George Poe.

William is given this brief notice here and not in his proper place after David and George because this record is of the Maryland Poes. No full data on others.

David Poe's early life was spent in Pa, where his father, John had settled and he had married the beautiful, Elizabeth Cairnes. In 1776 he moved to Baltimore and from that time was prominent in public affairs. He was Quarter Master General in the Maryland line, and contributed largely of his personal means, in furnishing arms and supplies to the soldies of the Revolutionary War. These contributions impoverished him. In 1799–1800, he was in the city council, and tho 73 years old took and active part in the Battle of North Point, September 12, 1814. The Marquis de la Fayette had a warm affection for him and on his visit to Baltimore in 1824, inquired particularly for him. Hearing he had died 8 years before, he expressed great sorrow and asked to be taken to the widow's residence to pay his respects to her. David Poe, died October 17, 1816. His widow died July 7, 1835.

David Poe and Elizabeth Cairnes Poe had 7 children:

- 1. John Hancock Poe-born Aug. 25, 1776, baptized Sept. 13, 1776 First Presbyterian Church.
- George Washinton Poe-born Aug. 21, 1782, baptized Oct. 6, 1782, Baltimore, First Presbyterian Church.
- 2. William Poe-born Mar. 2, 1780, baptized Apr. 14, 1780, First Presbyterian Church, Balitmore.
- 4. David Poe, Jr.- Born, July 18, 1784, baptized Sept. 21, 1784, First Presbyterian Church, Baltimore.
- 5. Samuel Poe born, Dec. 21, 1787, baptized Feb. 17, 1788, First Presbyterian Church, Balitmore.
- 6. Mary (Maria) Poe, -born, Mar. 17, 1790, baptized June 6, 1790, First Presbyterian Church, Baltimore.

7. Elizabeth Poe-born Sept. 26, 1792 baptized Dec. 16, 1792, First Presbyterian Church, Baltimore.

David Poe, Jr. was born in Baltimore in 1784, married in 1806 to Mrs. Elizabeth Hopkins, (nee Arnold) an English actress. She died in Richmond, Va. Dec. 8, 1811. He had died a short time before in Norfolk, Va. They had 3 children:

- 1. William Leonard Henry Poe-born Feb.-1907, died July 7, 1831.
- 2. Edgar Allan Poe-born Jan. 19, 1809, died Oct. 7, 1849.
- 3. Rosalie Poe-born Jan.-1810, died July 21, 1874.

Maia Poe born Mar. 17, 1790, was married at St. Paul's Church, Baltimore to Wm.

Clemm, Jr. son of Col. William and Catherine Clemm of Mt. Prospect, now Walbrook, Baltimore on July 13, 1817 by the Rev. William E. Wyatt. She was his second wife; his first wife was Harriet Poe, daughter of George Poe and Maria's first cousin. Their children were:

- 1. Henry-born Sept. 10, 1818, died unmarried.
- 2. Virginia Maria-born Aug. 22, 1820.
- 3. Virginia Eliza-born Aug. 13, 1922, died Jan. 30, 1847 (Edgar Allan Poe's wife)
 Virginia Elizabeth Clemm married her first cousin, Edgar Allan Poe, the
 poet. She was baptized by Bishop Kemp, Nov. 5, 1822 and died at Fordham, New York in the now
 celebrated cottage, Jan. 30, 1847.

William Clemm, Jr. died in South St. Baltimore, Feb. 8, 1826, was buried in the family lot in St. Pauls Cemetary just at the left of the German St. entrance. He is mentioned more fully in this record because from him and his first wife, Harriet, came all the descendants of Neilson Poe who married their daughter, Josephine Emily Clemm and because he was the father of Virginia, wife of the poet, Edgar Allan Poe.

Maria Poe, second wife and widow of William Clemm, Jr. died Feb. 16, 1871, was first buried in her father's lot No. 27 in Westminister Churchyard, Green and Fayette Sts. but her remains were transferred at the same time as those of the poet Edgar Allan Poe and they both now lie buried under the Poe monument in that churchyard.

Edgar Allan Poe, son of David, Jr. and Elizabeth (Arnold) Hopkins Poe, was married to his first cousin, Virginia Elizabeth Clemm in Richmond, Va. by the Rev. Mr. Converse, May 16, 1836. He died at Washington College (now the Church Home) on Broadway in Baltimore, Oct. 7, 1849 and was buried Oct. 9 in the lot 27 of his Grandfather, Gen. David Poe in Westminister Churchyard. His remains were removed, Nov. 17, 1875 to the spot in the same churchyard where they are now covered by the Poe monument.

Virginia, his wife, died at Fordham, New York, Jan 30, 1847 and her remains were brought from there and buried along side those of her husband, Jan. 19, 1885. With his death the name as far as the descendants of David Poe are concerned, is extinct.

This record will not attempt more than a sketch of the poet. Many lives of him have been written, namely:

Many other memoirs and lives have been published and the Magazines, from time to time, even now, present something, "Never before published", editions of his works almost every one of which contains a memoir, have been published in England, France, Germany, Spain, Italy, and Australia—i.e., in six countries and in five languages. Copies of his earlier poems (Editions) are almost beyond price. One of the first editions of Tamerlane, published in 1827, when he was only eighteen, sold for \$3000, dollars. One is in the British Musuem and beyond purchase and another in the Lennox Library, N.Y. Dodd Mead and Co. publisher, N.Y. own many of the early editions. of his works. His autograph letters command a high figure. In Nov. 1900, one sold at auction in Boston, for \$50 dollars and since then others — and his Manuscripts have brought extremely high prices.

Edgar Allan Poe was not buried by the late, Dr. J.J. Moran, as is frequently stated. The expenses of his funeral were paid by Neilson Poe, (of Jacob) and Henry Herring. Henry Herring married the Aunt of Edgar Allan Poe, Elizabeth (Eliza) Poe.

George Poe, son of John Poe and Jane McBride Poe, was born in Ireland, and was brought by his parents when only 2 months old to New Castle, Del. and then to Lancaster Co., Pa. near Little Briton, 1743. The family later removed to Cecil Co. Maryland where about 1775 George married Catherine Dawson. Soon after their marriage they moved to Baltimore and lived first on Thames St. "Fells Point" W. of Broadway, as it now, and afterwards to their own property, No. 183, Market St. This lot is mow on the south side on (Hanover St.) of Baltimore St. about three doors east of Hanover St. He was a private in Capt. Cox's Co. on duty 1775–1776. David Poe, his brother was a sargeant, later in Capt. McClellan's Co., David Poe was Lieutenant, George Poe, Sergeant, and William Poe, private.

George Poe, died at the home of his (Aug. 20, 1823, aged 82) son Jacob Poe, Elmwood, Frederick Co., Md. He was buried in the Buring gound of the Brick Meeting House, near Walkers-ville, Frederick Co. Md. The loss of the family Bible by fire makes it impossible to give the exact date of his and his brother David's birth.

Catherine Dawson Poe, wife of George Poer was born at Nottingham, Cecil Co., Md., May 13, 1742. She died at the home of her son, Jacob which was then at Harve de Grace, Md. Merchant and made several voyages as supercargo; afterwards he became a farmer; first near Havre

de Grace, then in Baltimore Co., and in 1817 at Elmwood, Frederick Co., Md. He was married

in Baltimore, Ja. 4, 1803 by Rev. Inglis to Bridget Amelia Fitzgerald Kenedy, and was born June

10, 1775, in the Co. Tipperary, Ireland, between Ninah and Tomavora, her father who lost all he

had by becoming surety for one John Branton, sailed from Dublin, in the ship Nepture-Capt. Roach

Apr. 30, 1784, and landed in Baltimore, May 20, 1784. Her mother was Amelia, Daughter of Geo.

Fitzgerald, counselor at Law. A picture of him belongs to Amelia Poe, his Great Grandaughter.

She Amelia Fitzgerald Kennedy, died at Salisbury Eastern Shore, Md. in 1790 and her body was brought to Baltimore and buried in the Roman Catholic Burial Ground on the site of old Calvert Hall, Saratogo St. opposite the Hotel Rennert. John Kennedy her husband died at St. Croix, West Indies, while on a visit to his brother James Kennedy. Some facts, trivial perhaps, concerning Bridget and her parents, have been handed down and deserve recital here. They brought with them from Ireland a Chalice, which had been used in the private Chapel, of their family, they were Roman Catholics, and in the time of Archbishop Carrol, she presented it to the Roman Catholic Cathedral Balitmore. They also brought some articles of silver and gold, which are curiosities.

A silver reliquary now owned by Amelia Poe is said to contain parings of the True Cross. In this Reliquary is also a raison seed brought from Palistine. It is in perfect condition although about 115 years old. A silver ring for a pin cushion now belongs to Neilson Poe, Jr. It belonged to Bridgets Grandmother, who was Bridget Keating, wife of GeorgeFitzGerald, and a great, great grandmother to its present owner. An old gold watch now owned by Amelia Poe, was given to AmeliaFitzGerald by her Uncle Redmond Keating. AmeliaFitzGerald was educated in a convent and was married from there. Thomas Francis Meagher, the Irish Patriot and exile, was her first cousin. Bridget was dedicated to St. Bridget and never wore a colored garment until she was 7 years old, when her mother painted waist ribbons for her.

The Coat of Arms of the FitzGeralds, and the Cress are both shown on pieces of silver brought over by John and Amelia FitzGerald Kennedy. The FitzGerald Crest, a mounted Knight in full armor, is upon a silver mug owned by Amelia Poe. Jacob Poe died at the house of his son Neilson. Lexington and Courtland Sts., Baltimore, Md. July 25, 1860, aged 85. He was buried at the Brick meeting house near Walkerville, Frederick Co., Md. It is interesting to note the great age attained by several of his near relatives. His Grandmother, Jane McBride Poe, lived to be 96, his father, George Poe, 81, his brother George, 86, his wife Bridget, 70, his son, George, 72, his son Neilson, 74, his

daughter, Amelia (Neilson's twin) 79. Bridget Amelia FitzGerald Poe died, Dec. 25, 1844 in the 70th year of her age at her home. (Elmwood) Frederick Co., Md. and was buried at the Brick Meeting House, near Walkersville, Frederick Co., Md.

Neilson Poe, son of Jacob and Amelia FitzGerald Kennedy Poe (Neilson had a twin sister, Amelia, that married Goldsborough) they were born in Baltimore, Aug. 11, 1809 in the house on the South side of Baltimore St., then Market St, a short distance east of Pine St. In early life he was a student of law in the office of Wm. Gwynn, a noted counsellor and editor of the Federal Gazette. Afterwards he was assistant Editor then Editor and owner of the Frederick Examiner and on his return to Baltimore, in 1835, became Editor and Proprietor of the Baltimore Chronicle. He was admitted to the bar before being of age and practiced in Baltimore until 1878, when at the request of Gov. Carroll, he accepted the Chief Judgeship of the Orphans Court, which place he filled until shortly before his death Jan. 1884. He was a constant contributor to many journals, and was distinguished by the beauty of his style and the elegance of his diction. He was married by the Rev. Thomas Jackson, an Episcopal Clergyman, Nov. 30, 1831, at Elmwood, Frederick Co., Md. to Josephine Emily Clemm, second daughter of Wm. Clemm, Jr. and Harriet Poe Clemm. She was

John Prentiss Poe--No attorney is better or more favorably known that the genial author of the Code of Maryland Laws.

Mr. John P. Poe is thoroughly identified with all the various interest of the city of Baltimore, having it his home since his birth which occurred, Aug. 22, 1836.

His parents Neilson and Josephine Emily Poe were also natives of Maryland,, the former during his lifetime, a well known member of the Bar.

John P. Poe was educated in the public schools of Baltimore and at the French and English Academy of Professor Boursard. Later he attended St. Mary's College and subsequently Princeton College, from which he graduated in June 1854, being at that time in his 18th year.

On his return from College, Mr. Poe secured a clerkship in a bank and during this time read law under the supervision of his father.

He was appointed Librarian of the Law Library which gave him an excellent opportunity of pursuing his studies.

Applying for admission to the Bar, his petition was granted in the Superior Court of Baltimore, August 22, 1857 in the Court of Appeals of Md. in December of that year and in the Supreme Court of the U. S. in January 1858, since which time he has been in active practice in the various State and Federal Courts.

From the first, Mr. Poe has taken an active part in all political movements of the State and Nation, advocating the principles of true Democracy.

In 1871, Mr. Poe was appointed school Commissioner for the 11th Ward serving upwards of seventeen years.

In 1885, he was appointed Pres. of the Baltimore City Tax Commission, and of the State Tax Commission of the following year.

Under the Administration as Mayor of the Hon. William Pickney White, Mr. Poe served as city Counsellor from 1882 to 1884 and later on was elected Attorney General of the State in 1891.

Mr. Poe is well known as an Author of Recognized authority on legal subjects, his "Pleadings and Practice in Courts of Common Law", first published in 1880, having passed through three editions, the last one being issued in 1897, the first one in 1882 to 1884.

Because of his eminent fitness for the work, Mr. Poe was appointed by the General Assembly in 1886 to prepare the Maryland Code of Public General and Local Laws, and his codification was adopted in the Act of 1888 and re-adopted in 1890. As a whole it is as complete and perfect a Code of Laws as can be found in any State of the Union. He prepared also the Baltimore City Code, 1885 and that of 1893. As early as 1869, Mr. Poe was elected a Regent of the University of Maryland and on the establishment of the School of Law of the University, he was appointed Professor and later became Dean of the Faculty.

As a practitioner at the Bar, Mr. Poe has had a long and successful career, his success dating back to his admission to practice.

As an author his reputation is firmly established and will remain bright and untarnished long after his call to the Bars above.

In political views Mr. Poe has always given his unswerving support to the standard bearers of Democracy. On the hustings or in the party councils, he has been a piller of the organization, and one who's council has been eagerly sought and highly esteemed.

In june, 1904, on the fiftieth anniversary of his graduation from Princeton, the degree of L.L.D. was conferred upon him by that University.

MORSES EXPERIMENT (A note on it)

Morses Experiment-Among the matters of special interest to be found in the Supplement to the Sun today is an article by the late Judge Neilson Poe, on the introduction of the electric telegraph. The reminiscences and correspondence embrace in the article form an Addition to the History of Great invention of Prof. Morse, well worthy of persual and preservation.

MORSES EXPERIMENT--TRIALS OF THE TELEGRAPH--HOW THE MATTER GOT INTO POLITICS

Learned men fighting shy of the invention. The Right was and the Congressional Appropriation. It's part in the Campaign of 1844. REMINISCENCES--

The history of the Invention and introduction of the electric telegraph, by Prof. Morse is one of inexhaustible interest and every incident relating to it is worthy of preservation. The incidents described below will be found of special interest. The article is from the pen of the late Judge Neilson Poe and was the last paper written by him. He prepared it during his recent sickness, the letters embodied in it from Mr. Wright and Mr. Latrobe being of course obtained at the time of their respective dates. It is as follows:

Reminiscences of the Telegraph.

On the 5th of April 1853, when the monthly meeting of the directors of the Baltimore and Ohio Railroad Co. was about to adjourn, the president, the Hon. Louis McLane, rose with a paper in hand which he said he had almost overlooked and which the secretary would read. It proved to be an application from Prof. Morse for the priviledge of laying wires of his electric telegraph alone the line of the railroad between Baltimore and Washington, and was accompanied by a communication from B.H. Latrobe, Esq. Chief Engineer, recommending the project as worthy, the project, of encourgement.

On motion of John Spear Nichols, the seconded by the Hon. John P. Kennedy, the following resolution was then considered: Resolved that the President be authorized to afford to Mr. Morse such facilities as may be requisite to give his invention a proper trial upon the Washington Road, provided in his opinion and in that of the engineer it can be done without injury to the road and without embarrassment to the operations of the Co. and provided Mr. Morse will concede to the Co. the use of the telegraph upon the road with expense, and reserving to the Co. the right of discontinuing the use if, upon esperiments it should prove in any manner injurious. "Whatever," said Mr. McLane, "may be our individual opinions as to the feasibility of Mr. Morse's invention, it seems to me that it is our duty to concede to him the privilege he asks and to lend him the aid in out power, especially as the resolution carefully protects the Co. against all present or future injury to it's works, and secures us the right of requiring it's removal at any time."

(In view of the fact that no railroad can now be run safely without the aid of the telegraph, the cautious care with which the right to remove it if it should become a nuisance was reserved, strikes one at this day as nearly ludicrous).

A short pause ensued, and the assent of the Co. was about to be assumed, when one of the old directors, famed for the vigilance with which he watched even the most trivial measure, begged to be heard.

He admitted that the rights and interests of the work were all carefully guarded by the terms of the resolution, and the Co. was not called upon to lay out any of its means for the promotion of the scheme. But not withstanding all this, he did not feel as a conscientious man, that he could without further examination, give his vote for the resolution. He knew that this idea of Mr. Morse, however plausible it may appear to theorist and dreamers, and so called men of science, was regarded by all practical people as destined, like many other similar projects to certain failure, and must consequently result in loss and lossible ruin to Mr. Morse. For one, he felt conscientiously scruplous in giving a vote which would aid or tempt a visionary enthusiant to ruin himself. Fortunately the views of this cautious practical man did not prevail. A few words

from the mover of the resolution, Mr. Nicholas, who still lives to behold the wonders he helped to create, and from Mr. Kennedy, without whose aid the appropriation would not have been passed, the House of Representatives, relieved the other directors from all fear of contributing to Mr. Morse's ruin, and the resolution was adopted. Of the President and the Thirty Directors who took part in this transaction only then, Samuel Smith, John Spear Nicholas and the writer, survive. Under it Morse at once entered upon that test of his invention, whose fruits are now enjoyed by the people of all the Continents. It was not, however, until the spring of 1844 that he had his line and its appointments in such a condition as to allow of the transmission of messages between the two cities, and it was in May of that year that the incident occured which his chiefly led to the writing of this paper.

In that month two conventions met in Baltimore to nominate candidates for President and Vice-President. The first chose, Mr. Clay and Mr. Frelinghayser, as the Whig candidates, and messages announcing their nomination are said to have been sent to Washington by the wires. The Democratic Convention met on the 27th of May with Mr. Henrdik B. Wright, of Pa. as its President. The Telegraph in Politics.

The following letter written by Mr. Wright to me nearly 40 years after, recites for the first time the history of the past, which Morse's electric telegraph had an influencing the policy and decission of the great Democratic Council of that day.

House of Representatives, Washington D. C. February 15, 1881.

My Dear Sir:

Your note of the 12th instant to Hon. Eli. J. Henkle, making inquiries as to some incidents connected with a telegraphic despatch from Silas Wright to me, placed in my hands with a request to make a reply. "The facts are all fresh in my memory except as to the individual who placed it in my hands. After a long and exciting conflict lasting some three days, the convention succeeded in the Nomination of Jas. K. Polk for Pres. It became necessary to secure the hearty concurrence

of the friends of Mr. Van Buren, who had been a canidate for the Pres. Nomination, and as you intimate it was deemed advisable to do this part of the business with despatch and adjourn as soon as practicable afterwards. Silas Wright was nominated for Vice-President by acclamation. He was then a U.S. Senator of Wash. and was officially informed of the Nomination. Before the final adjournment, a telegram addressed to me from him, refusing to accept the nomination, who laid before me which I ordered to be read. Through whose agency the despatch reached the convention chamber from the telegraph office I am not aware. At this time, May 1844, the only telegraph line in this country or any other connected the two cities of Wash. and Balto. Congress had given Mr. Morse aid in the construction of this Esperimental trial of his great invention. The dispatch, however, the Convention would not accept as authority, the members were incredulous. There was a committee appointed to proceed to Washington and confer with Mr. Wright on the subject of the nomination, and the Convention adjourned over to wait the return and report of their committee.

The foregoing substantially answers the inquiry contained in your latter. !I may add that I wrote out a statement of the above facts and mailed the letter to Prof. Morse as an interesting link in the Historical Chain of his world wide invention. It failed to reach him, as the communication came back to me through the dead-letter office a short time before the Prof's death.

It is scarcely necessary to add that this message to Silas Wright was neither framed or sent by a a document. The Whigs who were watching the proceeding of their adversaried with attention, were elated by it. They forsaw that if he could be forced to accept the nomination by an adjournment without giving him to opportunity of declining, the digusted adherents of Mr. Van Buren would again rally under the flag which had guided them to victory in past contests. They determined

therefore, at aconsultation that Silas Wright should have anopportunity to accept or reject his nomination, before the despersion of the convention. Mr. Vail, Mr. Morse's superentendant and partner was in the office of the Telegraph and to an inquiry from me whether he could send a message to Washington, his modest reply was, "I think I can." A message appraising Mr. Wright to his nomination was then framed by the writer of this paper and signed by Mr. Vail. In twenty minutes the reply came. "Mr. Wright is in the office here and positively declines." This message was attested by Mr. Vail and with as much despatch as possible laid by Mr. Means upon the desk of Hendrick B. Wright, Pres. of the Convention. What followed is sufficiently detailed in the letter if Mr. Wright of Feb. 15, 1881.

Conceiving that a Historical incident like this was not unworthy of being preserved with accuracy, I determined after a lapse of 37 years to appeal to the recollection of Mr. Wright who had survived most of the members of his Convention and was then a Representative in Congress. His answer proved most clearly that the message which the benevolence of the Whigs laid before him was the one which he received, and that the earliest achievement of Morse's electric telegraph was to make George M. Dallas, instead of Silas Wright, V. Pres. of U.S. in the years of our Lord, 1844. Neilson Poe.

Note—In the month of March 1881 I related the substance of the foregoing paper to Mr. John H.B. Latrobe who insisted that the incidents they recite were of sufficient interest of warrant their publication and he offered to send me some recollections of his own upon the introduction of the Magnetic telegraph. I annex these for the purpose of showing how the versatility of Mr. Latrobe's Genius led him through only the law adviser of the company to influence it's policy, at a critical period upon a question which only a mind bent to science as his is, could comprehend and appreciate, and for the more selfish object of redeeming this communication of mine from the risk of being pronounced an abuse of the liberty of the press.

MR. LATROBES'S RECOLLECTIONS.

My Dear Mr. Poe:

Agreeably to my promise this morning I put on paper my recollections of the introduction of the Magnet telegraph between Baltimore and Washington. I was Council of the Balto and Ohio Ry. Co. at the time and calling on Mr. McLane, the Pres. on some professional matter, was asked in the course of conversation whether I knew anything about an electric telegraph, which the inventor who had obtained anappropration from Congress wanted to lay down on the Washington branch of the road. He said he expected Mr. Morse, the inventor to call on him, when he would introduce me to him, and would be glad if I took an opportunity to go over the subject with him and afterwards let him, Mr. McLane, kmow what I though about it. While we were yet speaking Mr. Morse made his appearance and when Mr. McLane introduced me he referred to the fact that as I had been educated at West Point I might, the more readily understand the scientific bearings of Mr. Morse's invention. The President's office being no place for prolonged conversation it was agreed that Mr. Morse would take tea at my dwelling when we would take or go over the whole subject. We met accordingly and it was late in the night before we parted. Mr. Morse went over the history of his invention from the beginning with an enthusiasm that had survived the wearying toil of an application to congress, and with the aid of diagrams drawn on the instant made me master of the matter and wrote for me the Telegraphic Alphabet which is still in use over the world. Not a small part of what Mr. Morse said on this occasion had reference to the future of his invention, its influence upon communities and individuals and I remember regarding as the wild speculations of an active imagination, what he prophesied in this connection and which I lived to see even more than realized. Nor was his conversation confined to his invention, a distinguished artist, and educated gentleman an observant traveller, it was delightful to hear him talk and at this late day I recall few more pleasant evenings than the only one I passed in his company. Of course, my first visit the next morning, was to Mr. McLane to make my report. By this time I had become as inthusiastic almost as Mr. Morse himself, and repeating what had passed between us I soon saw that Mr. McLane was becoming as eager for the construction of the line to Washington, as Mr. Morse could desire. He entered warmly into the spirit of the thing and laughed heartily if not incredulously, when I told him that altho he had been Minister to England, Sec'y to Treasury, his name would be forgotten while that of Mr. Morse would never cease to be remembered with gratitude and praise. We then considered the question as to the right of the company to permit the plan of construction at that time being to bury in a trench some 8 or 10 inches deep, a half inch tube containing the wrapped wire that was to form the electric circuit. About this there was, in my opinion no doubt, and it was not long after that the work of construction commenced. I met Mr. Morse from time to time while he lived and often recurred this evening's discussion at my home in Baltimore.

The above is the substance of what I have more than once related to others. I hope you will persist in your design of putting on paper your own very interesting recollections and if what I have contributed of mine is of service to you I shall be much pleased.
