Mary Nicholson and John Nicholson by letter of Attorney dated 12 march 1750 recorded in the county of Essex

Did authorize John Champe in the names of Mary Nicholson and John Nicholson to sell and dispose of certain tract of land

(late of said Thomas Nicholson's) being in the county of Spotsylvania containing 1000 acres near the River Rappahannock, according to patent made to Thomas Nicholson dated 23 June 1732 whereas the said Samuel Donne having become

a purchaser of said tract of land being formerly in the county of Spotsylvania, but now in Culpepper being part of the 3000 acres of land granted to Henry William, Gentleman bearing date of October 10, 1730 and By William ordered to be Patented to said Nicholson . Witnesses: Robert Jackson ,Anthony Strother, Daniel Campbell, **William Poe, Nathan Nalle**, Wm McWilliams Jr., Roger Nixon, Mary Nicholson, John Nicholson and John Champs recorded Nov 16 1752
