Mrs. Penina Williams died at the home of her great-niece, Mrs. Joe A.Searcy, 403 Queen City Ave. Mrs. Williams had been in feeble health for several years, but had been rarely sick. During the last two weeks she suffered a decline in strenght, leading to her death today. Mrs. Williams at 99 the age of 99 years, was one of the oldest residents Tuscaloosa County. She was born at Newtonville, in the northern part of thes County, June 3rd., 1834-that was just three years after the opening of the University of Alabama. Her husband, the late Probate Judge B.H. Williams, died February 28 th., 1917-at the age of 95. He served two terms as Probate Judge in Tuscaloosa County, and two, also ,in Fayette County . Her immediate family established a remarkable record for their longevity. Just three weeks ago, her Aunt, Serepta McCool died in Benton, Arkansas, at the age of 103-and her mother, Mrs. Elizabeth Poe Nall, passed away at the age of 85 years. Her father, Bradley Nall, was 58 years old, when he fell a victim of the Civil War. Mrs. Williams had no children and her only immediate survivors were: Mrs. Joe Searcy, a great niece-Mrs. Sally Foster ,a niece-and ,W.J. Foster of Sherman , Texas, a great nephew. She resided on Hargrove Road until 25 years ago , when she moved to the city. She was active in Baptist Church work until a few years ago. Funeral services will be held from the Searcy residence on Queen Cith Ave. ,Friday morning at mime 11 O'Clock.Dr.L.O.Dawson,former Pastor of of the First Baptist Church ,and Dr.Powhatan B.James, present pastor, will officiate, with Jones and Spigener directing.
