Leon,

Conflating, yes indeed. Here in DC I have looked through DAR folders that make a claim for membership, and the Poe files are a mess. They don't seem to want to talk to me about it – seems once people get through and become members, they don't visit the information. Two are really horrible.

John Poe of VA. In fact, this is the family of a Balzer Poe of German origin that settled around Winchester, VA and after the war of 1812 got land in Ohio . . . but the file conflates this family with a different Poe family that ended up on Johnson County, IN and may be the same John Poe who was in the 1771 Silar City, Chatham County, NC muster roll of 1771. And as I recall, that wasn't the only confusion.

Then there is the Samuel Poe of Culpeper County, who line William Eric Poe of the DNA project is in . . . and is almost surely son or grandson of William Poe/Lydia not least because that family has always lived in the same area of VA. But he is conflated with the English Samuel Poe who was in the French and Indian War and settled finally in Campbell Co, VA (and about whom I know nothing – did he marry, had children? Never seen any records), and there are other confusions over which of these Samuel Poe is which). But from the Samuel Poe of Culpeper County, the family line to Eric Poe is well researched.

I don't think I have really dug into the various Rev War claims for any of the William Poe, though I am pretty sure that the William Poe in the muster roll of 1771 and John Poe in the same roll moved together to Wilkes County, NC in the 1787 census. I am not sure what happened to either, but there are lots of theories about them. It is believed (by me at least) that this William Poe and John Poe were close kin to Stephen Poe who got Rev War land in Franklin Co, GA and whose family (and maybe him) ended up in Benton / Calhoun County, Alabama. And also a close kin relationship with the Rev War Henry Poe whose family seems to have moved into TN. Then there is Edmond Poe also connected, especially to Stephen Poe . . . and he did end up in Benton / Calhoun County, AL.

There is also a Rev War connection with the Thomas Powe family of Cheraw Dist, SC and a William Erasmus Poe. This William Poe makes an appearance in Wilkes Co. NC in 1792, but I think it was a business dealing – that family seems to have gone into the lumber business.

Hi William,

Thanks for this. I'll certainly let you see Leonard's results and documents he sends me. So far he's only sent me the court record for John Poe and his other remarks have been about what's he's been looking through. He delays drawing a line to say that's as far as he can go but I think we'll be at that point soon.

Where we're at seems to be that WRP is 'probably' associated with Wm Powe the Rev War veteran who died in Garrard County and who is the certain ancestor of Eva Monnet's ancestor William Poe who married Sally Harris. It's a great pity that none of Eva's Poe cousins have taken part in the project as that could confirm a connection; or even if it didn't and linked to others that may be of some help geographically. Rev War William is associated with a 'John Poe' who pays tax in Garrard and lived close by Rev War William so is probably a relative and the John Poe who served with William. But there's no record of his marriage or what became of him.

I'll review what I have so far and get back to you with my next best guess of a possible connection worth checking. Because there are so many documentary gaps and some unattached people it feels like anything is still possible through some options are less probable than others. In addition to unmatched Poes (like mine), there are unattached Poe's not linked to the DNA project. For example, the Col Wm Poe from Richmond who had been claimed by one of WRP's daughters now seems to be s different and older person. He left VA and freed his slave and no-one seems to have claimed his 1812 entitlements and although he married I can't find any record of children though I'd guess there were some. It feels like some of the online genealogies conflate different people into one and link people too easily, all of which opens up lots more options. It feels like it could be a decade-long project to sift all the 18C VA Poe / Powe and similar families - to say nothing of the rest.

Dear William,

Leonard Butts has been bitten by the bug about finding William Romulus Po(w)e's parents and I feel that he's putting more time into the project to try and find some more concrete answer. So, whatever the outcome I'll be happy to recommend him.

We've had some discussion about the DNA. Although I let him know that the DNA evidence suggested that William and Lydia of Orange County VA might be discounted I ended up saying that I thought he should follow where the documentation lead.

At the moment he is focussing on Garrard County court records which 'should' exist for John Poe and two mulatto children he brought from NC and which the Court took off him while it considered things. In spite of this, he doesn't think there was time for the Poes to be to and fro between NC and KY regularly. This John is in a few tax records but he disappears by 1810 and there's no evidence of his marriage. He is a possible candidate for WRP's
