Orange Co. Court Minutes Book: Court held March 1757 - "Thomas Laxton, Jr., and Samuel Cobb proved their attendance as Evidences in the suit - Taylor vs Reynolds". Court held August 1760 - "Ordered that **Nathaniel Hart**, **David Hart**, Thomas Highs, Edmund Denny, Daniel McCullom, Samuel Cobb, John Cantrel, John Thrasher, Robert Wells and Samuel **Watt** be appointed to lay out and open a road from the McCollom's Plantation to Taylor's Road leading to the Court House". Court held August 1763: - "Ordered that Henry Cobb be appointed overseer of the Lower Town Road from the County Line to John Cantril's and that all hands on the waters of the County Line Creek assist".

In 1761, Samuel **Cobb** recorded a land grant on County Line Creek for 487 acres, adjoining **Nathaniel Hart**.
